5 . Methods and forms of pedagogical assessment of learning outcomes

Forms of students' knowledge control are current and final control.

Current control of students' knowledge includes:

- quality control of students' assimilation of the program material of the educational discipline in practical classes using the following means: oral/written survey, express survey, solving practical tasks, participating in the development of a case, preparing a presentation, essay, abstract, etc. The current control is aimed at checking the level of the student's preparation in studying the current material. In the course of the practical session, the student can receive an assessment on a four-point scale (0, 2, 3, 4);

- quality assessment of the students' acquisition of the program material, which is conducted at the end of the modules in the form of tests.

An obligatory form of individual work of students is the preparation of a final written work. The maximum number of points based on the results of the defense of the final written work is 20 points.

The form of final assessment of the knowledge of higher education students in an academic discipline is a differentiated assessment. Minimum number of points to receive differentiated assessment - 60 points.
